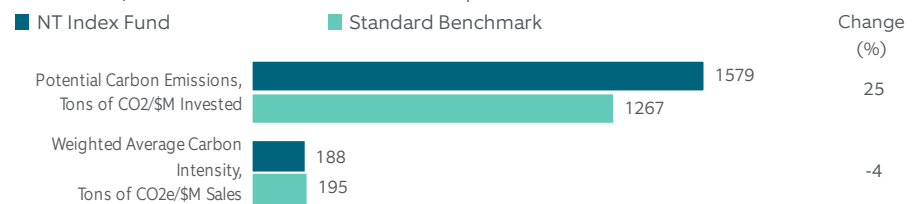
Engagement by Theme
