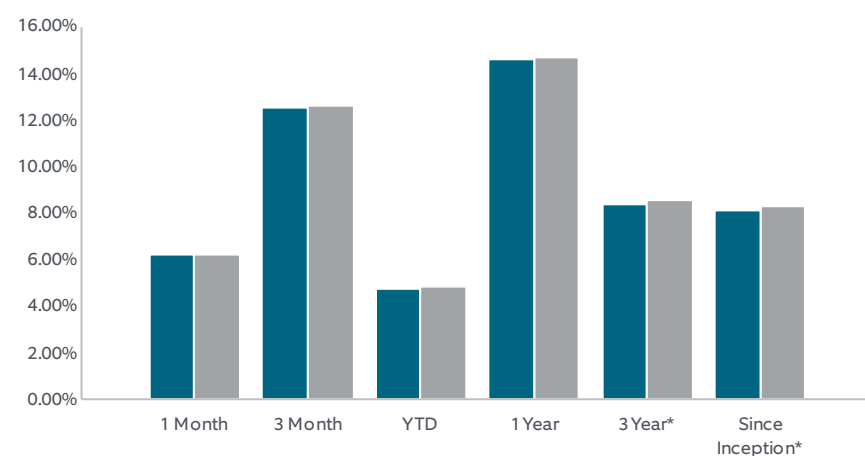
Investment Objective

The Fund seeks to closely match the risk and return characteristics of the MSCI World Custom ESG 100% Hedged to EUR Index (Index). It is a custom Index calculated and screened by MSCI based on Environmental, Social and Governance (ESG) criteria selected by Northern Trust which excludes certain companies not considered to meet socially responsible principles.

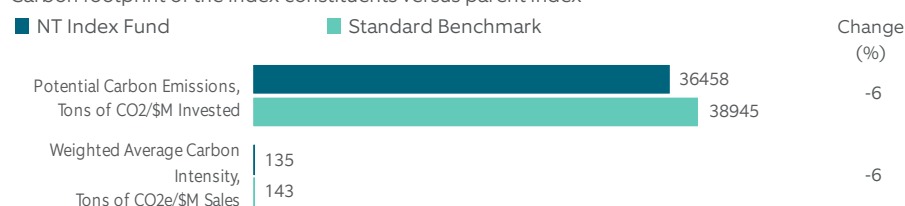
