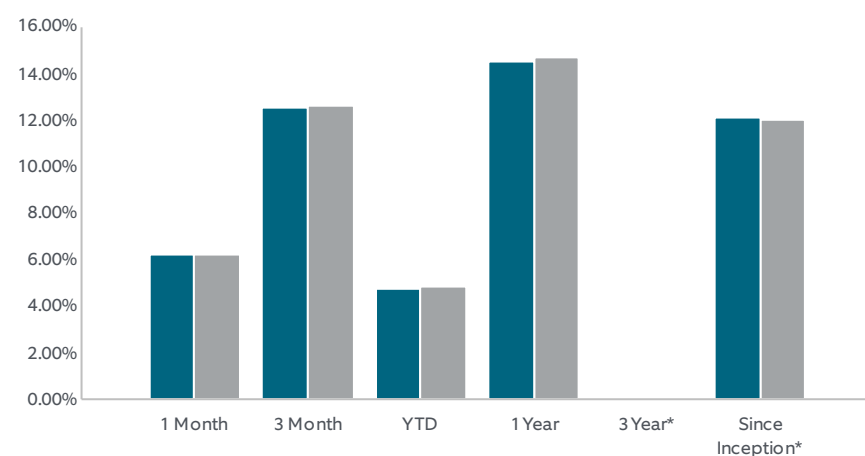
## Investment Objective

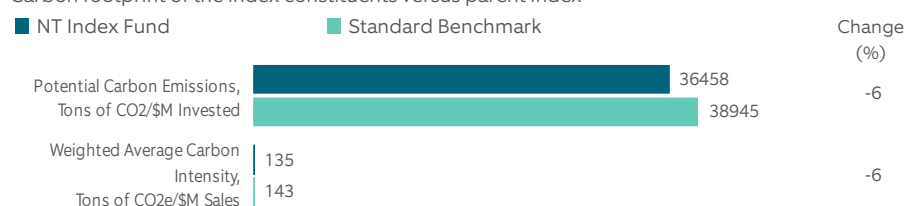
