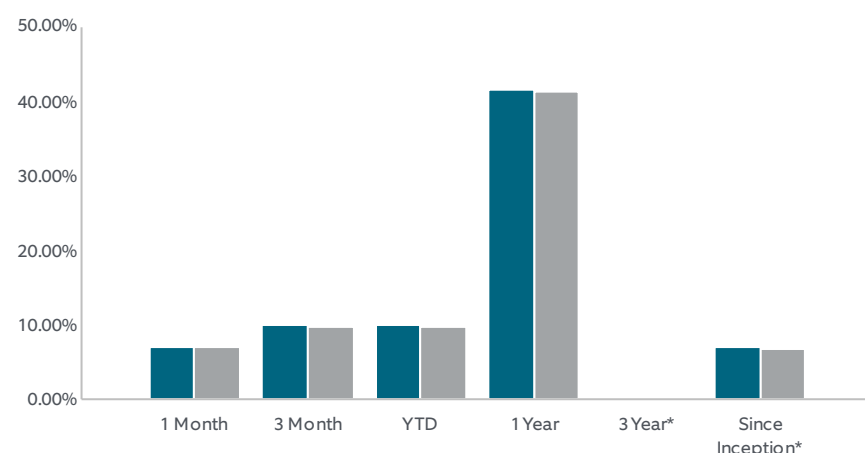
Investment Objective

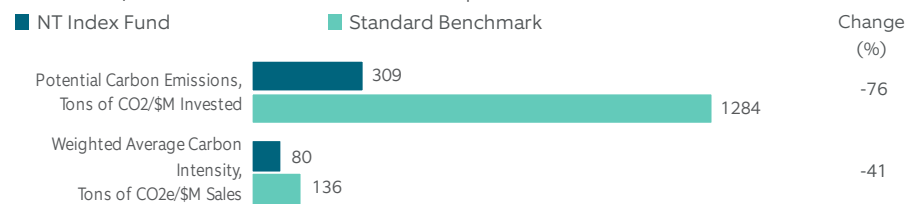
Engagement by Theme
