Amongst other things, the Index is looking to minimise climate related risks and maximise climate related opportunities.

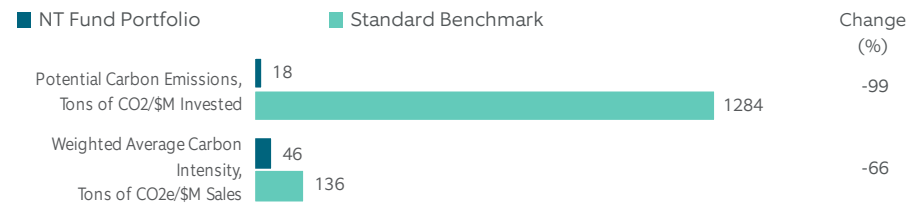
