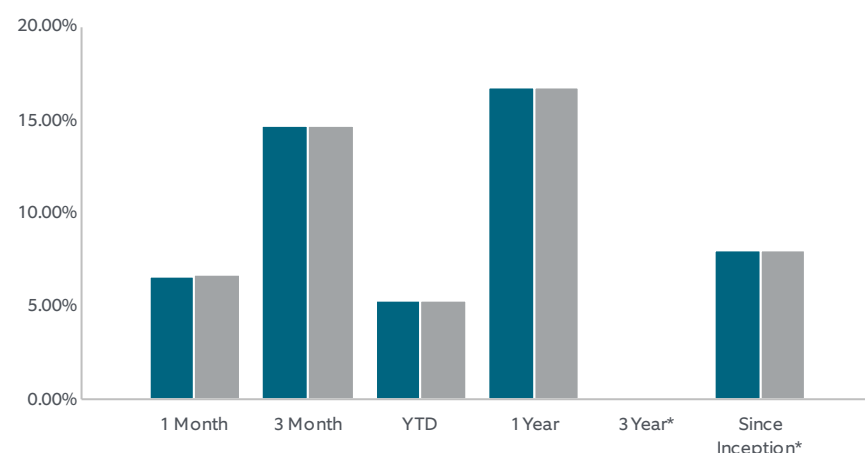
## Investment Objective

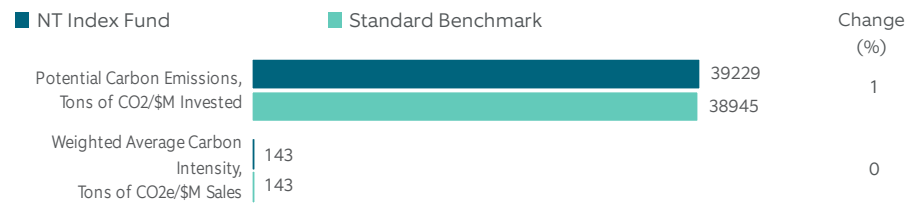
Engagement by Theme
