The Sterling Ultra ESG Fund seeks to provide yield in excess of money market funds with lower volatility than short duration bond funds. It strives to maintain a target duration of 12 months and is intended for investors with an investment time horizon of nine to eighteen months. Based on proprietary fundamental research the Fund invests in higher quality Sterling denominated investment grade government, corporate and asset backed securities, with a maximum duration of five years, and applies exclusionary ESG screens whilst integrating sustainability into the investment process.
