OBJECTIVES AND INVESTMENT POLICY

The Fund is a UCITS feeder fund. The Fund's investment objective is to invest at least 85% of its assets in the Northern Trust Europe Value ESG Fund (the "Master Fund") a Sub-Fund of the Northern Trust UCITS Common Contractual Fund, the investment objective of which is to deliver long-term capital growth by investing in securities issued or linked to companies within the MSCI Europe Index which exhibit value, quality and momentum factors excluding securities that do not meet certain environmental, social and governance ("ESG") criteria.

The Fund may invest up to 15% of net assets in aggregate in ancillary liquid assets including cash deposits, cash equivalents, certificates of deposits and Money Market Instruments which may be held by the Fund to meet expenses or pending investment.

The Master Fund is managed in reference to the Index where the majority of the securities will be components of the Index however the Fund will have different weightings to the Index.

The Master Fund invests in equities and equity related securities (that is, shares and other similar kinds of assets) issued by companies or linked to companies in the Index. The Investment Manager may use its discretion to invest in securities not included in the Index in order to take advantage of specific investment opportunities.

The investment returns of the Fund are expected to be similar to those of the Master Fund.

Target Market: This Fund is appropriate for investors who plan to invest over the medium to long term; and are looking for an actively managed investment in the relevant market(s) with ESG principles implemented according to a defined set of exclusions as well as assessment of ESG ratings.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

This Fund may be appropriate for investors who can benefit from the tax status of the FGR fund range.

The Master Fund will exclude securities that do not meet certain ESG criteria and companies that are in breach of the UN's Global Compact Ten Principles, ESG criteria selected by the Investment Manager. The Manager considers that the Fund meets the criteria in Article 8 of the Sustainable Finance Disclosure Regulation (Regulation EU/2019/2088) to qualify as a financial product that promotes, among other characteristics, environmental or social characteristics. The Fund may invest in derivatives (currency forwards and exchange traded futures) for hedging purposes only. The Master Fund, for efficient portfolio management may invest in derivatives and other financially linked instruments (such as currency forwards and exchange traded futures) to reduce risk, minimise costs or generate additional capital or income. A derivative is a financial contract whose value is derived from other assets.

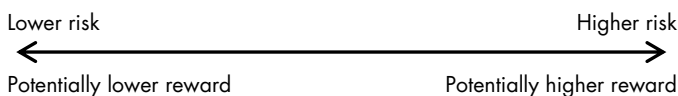
Income gains on your units can either be distributed or re-invested annually at your request.

You can buy or sell units daily (on each business day of the Fund). An application must be received by the Fund's administrator before 11.00am (Dutch time) on the relevant dealing day.

The A, C, E, G, I, K, M, O, Q, S, U, W and Y Classes of Units are issued to Investors which are subject to income tax. If investments are made by way of nominated accounts, it is possible that any of these Classes of Units are also issued to Investors which are exempt from income tax or entitled to a full refund of Dutch dividend withholding tax.

The base currency of the Fund is Euro.

A charge may be applied to the Fund by the Master Fund, to meet any transaction costs by the Master Fund which will be retained within the Master Fund.

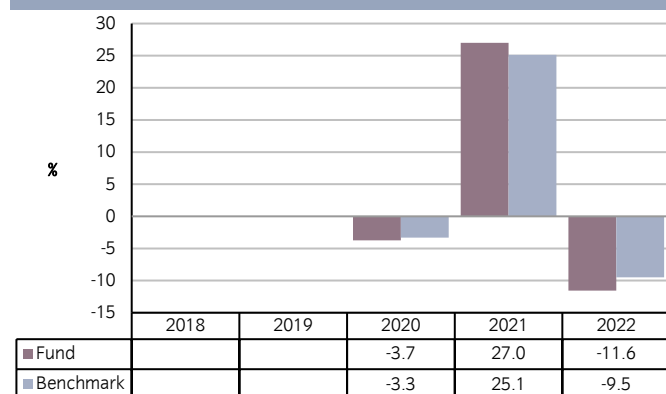
The on-going charges figure is based on expenses for the period 31 December 2022. This may vary from year to year. It excludes:

- **Tax Legislation:** The Fund is subject to Dutch taxation legislation which may have an impact on your personal tax position as an investor in the Fund. In addition, the fact that the Master Fund and Fund are not established in the same legal jurisdiction may also impact on your tax treatment. Investors should contact their own tax advisers before investing in the Fund.
- **Liability:** Northern Trust Fund Managers (Ireland) Limited ("NTFMIL") the Management Company may be held liable solely on the basis of any statement contained in this document that is misleading, inaccurate or inconsistent with the relevant parts of the prospectus.
- **Switching:** It is possible to exchange your units in one sub-fund for units in another sub-fund of the FGR. Details on exchanges of units are provided in the prospectus. An exchange charge may apply.
- **Umbrella Fund:** The Fund is a sub-fund of the FGR, which is an open-ended umbrella fund for joint account (fonds voor gemene rekening) without segregated liability between Funds*, with no legal personality and each Fund comprises a separate portfolio of assets. The FGR and the Fund is a contractual arrangement between NTFMIL and Stichting Bewaarder Anchor NL Beleggingsfondsen (the "Legal Titleholder"), where the assets of the FGR will be held by the Legal Titleholder for the risk and account of the investors. *Section 4:45 of the Dutch Act on the Financial Supervision (AFS) details the order in which assets of a Fund can be used to cover claims. Liabilities relating to the management, custody and holding of legal title of the assets will be settled first, followed by liabilities to investors in the Fund. If there are any surplus assets, these can be used to settle claims of another Fund. The Master Fund is a sub-fund of Northern Trust UCITS Common Contractual Fund, which is an umbrella Fund with segregated liability between Funds and authorised by the Central Bank of Ireland.
