

## Article 10 Information Statement

Issued by Northern Trust Fund Managers (Ireland) Limited

In respect of

**Northern Trust World ESG Leaders Equity Index FGR Fund (the “Fund”), a sub-fund of Northern Trust UCITS FGR Fund (the “FGR”)**

Date of initial publication of this Information Statement: 8 March 2021.

This Information Statement is accurate as at: 8 March 2021.

This Information Statement has been prepared for the purpose of meeting the specific website financial product level disclosure requirements contained in SFDR and, specifically, the disclosure requirements applicable to an ESG Orientated Fund under Article 10 of SFDR.

In this Information Statement the following words and phrases have the meanings set forth below:

“European Commission Letter”	a letter from the European Commission to the European supervisory authorities on the application of SFDR dated 20 October 2020 available <a href="#">here</a> .
“ESG”	environmental, social and governance.
“ESG Orientated Fund”	a fund that meets the criteria in SFDR to qualify as a financial product (which includes a UCITS) and promotes, among other characteristics, environmental or social characteristics, or a combination of those characteristics and provided that the companies that the fund invests in follow good governance practices.
“Master Fund”	Northern Trust World ESG Leaders Equity Index Fund a Sub-Fund of the Northern Trust UCITS Common Contractual Fund.
“SFDR”	the Sustainable Finance Disclosure Regulation (Regulation EU/2019/2088) as amended and as may be further amended from time to time.
“Sustainability Risk”	an environmental, social or governance event or condition that, if it occurs, could cause a negative material impact on the value of the investment.
“Sustainable Investment”	means an investment in an economic activity that contributes to an environmental objective, as measured, for example, by key resource efficiency indicators on the use of energy, renewable energy, raw materials, water and land, on the production of waste, and greenhouse gas emissions, or on its impact on biodiversity and the circular economy, or an investment in an economic activity that contributes to a social objective, in particular an investment that contributes to tackling inequality or that fosters social cohesion, social integration and labour relations, or an investment in human capital or economically or socially disadvantaged communities, provided that such investments do not significantly harm any of those objectives and that the investee companies follow good governance practices, in particular with respect to sound management structures, employee relations, remuneration of staff and tax compliance.
“Taxonomy Regulation”	the Regulation on the Establishment of a Framework to Facilitate Sustainable Investment (Regulation EU/2020/852) as may be amended from time to time.

All other defined terms used in this Information Statement shall have the same meaning as in the supplement for the Fund or the prospectus of the FGR, as appropriate, which are also available at <https://www.fgrinvesting.com/en/fund-range/>.

## 1 Sustainable Finance Transparency

The European Union has introduced a series of legal measures (the primary one being SFDR) requiring firms that manage investment funds to provide transparency on how they integrate sustainability considerations into the investment process with respect to the investment funds they manage.

This Information Statement has been prepared for the purpose of meeting the website disclosure requirements in Article 10 of SFDR.

It is noted that the application of the regulatory technical standards ("**RTS**") to specify the details of the content, methodologies and presentation of the information to be disclosed under Article 10 of SFDR have been delayed and will not be effective when the relevant disclosure obligations in SFDR become effective.

It is noted that the European Commission Letter has recommended that from the effective date of SFDR, firms are recommended to comply with the specific disclosure obligations in SFDR that are reliant on RTS on the basis of a high-level, principles-based approach.

We therefore seek to comply on a best efforts basis with the relevant disclosure obligations and issue this Information Statement as a means of achieving this objective.

It is expected that this Information Statement will be reviewed and updated once the relevant RTS come into effect, noting in particular, that the RTS are expected to contain details on the content, methodologies and presentation of the information to be disclosed and this could therefore require a revised approach to how we seek to meet the SFDR disclosure obligations.

The Information Statement may also be updated to take account of the Taxonomy Regulation.

## 2 Article 10 Disclosures

Information on how the environmental and/or social characteristics promoted by the fund are met	<p>The investment objective of the Fund is to invest at least 85% of its assets in the Master Fund, the investment objective of which is to closely match the risk and return characteristics of the MSCI World ESG Leaders Index (the "<b>Index</b>") with net dividends reinvested.</p> <p>The Index is a capitalization weighted index that provides exposure to companies with high Environmental, Social and Governance ("<b>ESG</b>") performance relative to their sector peers, based on MSCI's ESG ratings. Companies found to be in violation of international norms (for example, facing very severe controversies related to human rights, labour rights or the environment) and companies involved in controversial weapons (landmines, cluster munitions, depleted uranium, and biological and chemical weapons) are excluded from the Index.</p> <p>The Investment Manager of the Master Fund shall also ensure that any investments made by the Master Fund pursuant to the foregoing strategy are in accordance with rules regarding cluster munitions laid down in the relevant national legislation adopting the Convention on Cluster Munitions.</p> <p>The Investment Manager of the Master Fund has appointed Hermes Equity Ownership Services to carry out corporate engagement with carefully selected companies held within the Master Fund.</p>
Information on the methodologies used to assess, measure	The Index excludes certain companies not considered to meet socially responsible principles.

<p>Information on the manner in which sustainability risks are integrated into the investment decision-making process</p>	<p>As part of the process to undertake appropriate due diligence on investments, the Investment Manager of the Master Fund will generally conduct a level of research on each company or issuer. This may include a consideration of fundamental and quantitative elements such as financial position, revenue, capital structure etc. It may also involve qualitative and non-financial elements such as the company's approach and/or industry relative standing to ESG factors and consideration of Sustainability Risks. The Investment Manager of the Master Fund considers that material ESG issues are business issues; when managed well, these factors can position a company for success. When managed poorly, they can lead to negative externalities that can result in reputational and financial risk.</p> <p>The Investment Manager of the Master Fund integrates these ESG factors and this Sustainability Risk assessment into its investment research process, portfolio construction, and/or its risk management process – both initially and on an ongoing basis for the duration of the period the Master Fund holds an investment or pursues a particular investment strategy.</p> <p>In respect of the Funds, the investment approach of the Investment Manager of the Master Fund and decision-making processes are based on clearly defined investment objectives, investment policies, investment strategy, investment restrictions and risk management parameters, as contained in the relevant Supplement of the Master Fund.</p> <p>Using both quantitative and qualitative processes, further details on which may be set out in the relevant Supplement, Sustainability Risk is identified, monitored and managed by the Investment Manager of the Master Fund in the following manner:</p> <ul style="list-style-type: none"> <li>• Prior to acquiring investments on behalf of a Fund, the Investment Manager of the Master Fund uses ESG metrics of third party data providers (“<b>Data Providers</b>”) in order to screen the relevant investment against Sustainability Risk and to identify whether it is vulnerable to such risk. This process incorporates applying both an</li> </ul>

	<p>exclusion policy (whereby potential investments are removed from the investment universe on the basis that they pose too great a Sustainability Risk to the Master Fund) and integration of additional ESG approaches, where relevant.</p> <ul style="list-style-type: none"> <li>• During the life of the investment, Sustainability Risk is monitored through the review of ESG data published by the issuer (where relevant) or selected Data Providers to determine whether the level of Sustainability Risk has changed since the initial assessment has been conducted. Where the Sustainability Risk associated with a particular investment has increased beyond the ESG risk appetite for the relevant Fund, where applicable, the Investment Manager of the Master Fund will consider selling or reducing the Fund's exposure to the relevant investment, taking into account the best interests of the Unitholders of the Master Fund.</li> </ul>
Information on the results of the assessment of the likely impacts on sustainability risks on the returns of the Fund	<p>Factoring an assessment of the likely impact of Sustainability Risk into the investment design and decision making process has the potential to impact the returns of the Fund.
