

## NORTHERN FUNDS EQUITY AND FIXED INCOME FUNDS 2020 ESTIMATED CAPITAL GAIN DISTRIBUTIONS

Northern Funds will pay 2020 capital gains on **December 17** for shareholders of record as of **December 16**. These amounts are estimates as of September 30, 2020 and may change based on final tax adjustments and differences in total fund shares.

Payment or reinvestment of these distributions will be made based on the instructions you have previously provided. The actual distribution amounts will be reported on your year-end statement and on your Form 1099-DIV, which will be mailed to you in January 2021. Final distribution amounts will also be available after December 20, 2020 on [northerntrust.com/funds](http://northerntrust.com/funds).
