

NORTHERN FUNDS EQUITY AND FIXED INCOME FUNDS 2021 ESTIMATED CAPITAL GAIN DISTRIBUTIONS

Northern Funds will pay 2021 capital gains on **December 16** for shareholders of record as of **December 15**. These amounts are estimates as of October 31, 2021 and may change based on final tax adjustments and differences in total fund shares.

Payment or reinvestment of these distributions will be made based on the instructions you have previously provided. The actual distribution amounts will be reported on your year-end statement and on your Form 1099-DIV, which will be mailed to you in January 2022. Final distribution amounts will also be available after December 20, 2021 on northerntrust.com/funds.
