

## NORTHERN FUNDS AND NORTHERN INSTITUTIONAL FUNDS 2017 CAPITAL GAIN DISTRIBUTIONS

At least once a year, mutual funds must distribute to shareholders any capital gains realized from selling securities within the funds. In 2017, Northern Funds and Northern Institutional Funds paid capital gain distributions on December 21 to shareholders of record as of December 20.

The table below lists per share distribution amounts — dividends and short- and long-term gains — for both Northern Funds and Northern Institutional Funds. These amounts will also be reported on year-end statements.
